The price per share applied to redemptions shall be the net asset value of the particular fund on the first day of the month following the redemption notice. Investors will incur any applicable charges associated with redemption payments made via wire transfer.

Partial redemptions of a minimum of \$5,000 shall be permitted. However, if the remaining value after partial redemption results in a holding of less than \$5,000, an investor may be required to redeem their entire investment. Redemption Fees may be charged upon the redemption of Shares at the rate specified in the applicable Sub Fund Supplement, and in order to facilitate the long-term investment objective of the fund.
